RE: Urging Federal Protection and Investment in Head Start

Dear Chair Lofgren, Dean Calvert, Senator Padilla, Senator Schiff, and Members of the California Congressional Delegation,

As members of the California State Legislature, we urge your continued and unwavering support for the **Head Start** programs that serve over **85,000 children and families** across California each year. These programs are foundational to our state's early childhood education, home visiting, and family support infrastructure — and are deeply aligned with our shared goals of advancing opportunity, equity, and economic resilience.

California receives nearly **\$1.5 billion annually in federal Head Start funding for our local communities**, supporting a vast and diverse network of high-quality early learning and comprehensive family services in across the state [1]. Early Head Start, in addition to providing child care, plays a crucial role in our **home visiting landscape**, offering weekly in-home visits by trained professionals for families with infants and toddlers. Together, these evidence-based services have been shown to strengthen parent-child relationships, increase child development outcomes, reduce instances of child maltreatment, and support parents in achieving stability through education or employment [2][3][4][5].

At a time when working families face rising child care costs and economic instability, Head Start also serves as essential workforce infrastructure in California. Access to reliable early education supports parents to work or pursue training, and early childhood jobs — many held by women of color — support community well-being and economic mobility [5]. The current lack of child care access is estimated to cost California **\$17 billion in lost productivity and economic output each year** [6], cuts to Head Start would exacerbate this loss.

Head Start's economic impact extends far beyond the direct \$1.5 billion dollar investment in services. Head Start providers employ over 26,000 Californians, who spend those earnings in the state. Head Start providers also utilize thousands of contractors, for services ranging from accounting, to tree trimming, to gassing up school busses – all of which are threatened by proposed cuts.

We are therefore deeply alarmed by the April 1 closure of half of the Regional Offices supporting Head Start providers (including the office serving California) and recent reports indicating that there are **active policy discussions within the Trump administration to eliminate Head Start entirely** [7]. While no formal proposal has been introduced, this news — combined with recent budget freezes and proposed cuts — raises serious concerns about the future of early learning for millions of children across the country. The loss of Head Start would be devastating for California — displacing tens of thousands of children, eliminating thousands of jobs, and disrupting services that are often unavailable elsewhere, such as developmental screenings, mental health care, and family case management.

As such, we respectfully urge you to:

- **Reject any proposals that weaken or eliminate Head Start;**
- **Preserve and grow federal investments in Head Start**, including full funding for workforce and capacity-building needs and expanding access for children;
- **And champion Head Start as a vital part of California and our nation's early learning and care system.**

This is a moment to reaffirm our commitment to young children and families, especially those furthest from opportunity. We are grateful for your leadership and urge you to stand firm in defending and advancing these essential programs.
